Minutes Review

- R. Clark sent out the minutes from the February 17, 2021 meeting to all NYSLC Representatives to review
- The minutes from the February 17, 2021 meeting, were reviewed by all Representatives
- Motion by M. Hout to accept the minutes, second by DJ Paulson (Passed unanimously)

Presidents Report

R. Clark

- Pay Raises
- Started 2021 season with our correct pay rates the first day of the season

- OCS will pay retroactive pay for lifeguards who worked the summer of 2020 around 8/24/21

Riverbank

- Improper practice filed in the NYC Region
- Riverbank wasn't open and put the lifeguards at other parks and 2 days at Riverbank for training
- Wanted a guard to swim 500 yards with the water temperature at 80 degrees and the air temperature at 65 degree
- Memo pulled no daily training mandate, however lifeguards need to perform all training in the appropriate timeframe.

Lack of Dues

- R. Clark is pushing for online enrollment
- OCS didn't upgrade pay serve
- Pay serve didn't accept the file form NYSUT
- 505 lifeguards didn't get the correct deductions
- Parks will send out a letter on or about August 18 letting members know that they will be taking out retroactive union dues over the next 3 pay checks
- R. Clark is also drafting a letter to members as well
- R. Clark has formed great relationships with management in other Regions

Grievances

- ADID- Anti Discrimination Investigative Division
- ADID investigates discrimination against protected classes
- Work thought New York State
- 2 lifeguards off the payroll for sexual harassment
- New York State isn't messing around with sexual harassment/discrimination
- Saying something/comment only one time can start an investigation. It doesn't need to be persistent
- Lifeguards should look at the GOER policy
- Texts and cyberbullying will also start an investigation
- R. Clark will talk with R. Alden to get all updated required policies to all parks
- Green Lakes State Park had a submersion
 - Lifeguard in the best spot to respond didn't address it
 - Lifeguard didn't do anything
 - o Other guards responded
 - Lifeguard was fired for failure to follow the EAP
 - Had less than 3 years' experience
 - Didn't have an exit interview
- In an exit interview lifeguards can have representation and can be told why they don't want to rehire you
- Let R. Clark know as soon as possible about this
- Lifeguards can get personal records-they are only kept for one year
- If a lifeguard receives an advisory for something (coming in late) lifeguard can tell their side of the story

- By singing the advisory it doesn't mean you agree with it, it means you have received it and saw it
- Workplace violence stays in the region

Treasures Report

- B. Smith
 - 2020 after two paychecks UUP received \$28,534
 - 2021 after two paychecks UUP received \$4,730
 - NYSLC is in the hole \$24,000
 - This is due to the union dues not being taken out of the pay checks
 - \$68,327.39-as of 1/7/21
 - \$360 winter Representative Assembly
 - \$110.58 vaccine mailing
 - \$9,912.94 Dues 12/19, 1/20, 3/20, 5/20
 - \$156 Audit committee/fundraiser for JBLC
 - \$10,000 to JBLC for 2020 return to chapter
 - \$46,248.71 current
 - \$457 outstanding JBLC
 - 2020 at this point in time NYSLC had \$66,00 NYSLC is \$20,000 short in 2021
 - Return to chapter cannot be double yet

- All parks were short staffed especially at the end of the season
- Not able to work overtime in order to help with end of season shortages
- Management told the Chiefs how to run their beaches/pools with how many guards they needed without taking into consideration the Chiefs input

- Compared parks to each other with how many lifeguards they needed on staff and not the number of chairs and open beach that each park had
- Started out with great weather and was busy but has died down due to the weather
- T. Mondello lead a membership drive, many retuning lifeguards were not on the member list.
 - Sent forms out electronically and emailed them to R. Clark to submit
 - Several shifts in management
- Triathlon on 8/14/21
- Purchased RTIC insulated water bottles for members
- Niagara Region lifeguards were Lifeguard Instructor Certified/ recertified and were compensated for the time
- NYSLC Niagara Region Instagram account was created
- No lifeguard COVID-19 cases
